PRIVACY NOTICE

The Isle of Man Veteran Athletes' Club (IOMVAC) is committed to protecting and respecting your privacy. For any personal data you provide for the purposes of your membership, IOMVAC is the Data Controller and is responsible for storing and otherwise processing that data in a fair, lawful, secure and transparent way.

What personal data we hold on you

You may give us information about you by filling in forms at an event or online, or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you register with the Club. The information you give us may include your name, date of birth, address, e-mail address, phone number, name of the EA affiliated Clubs with which you are registered and gender (Athletics Data).

Why we need your personal data

The reason we need your Athletics Data is to be able to administer your membership, and provide the membership services you are signing up to when you register with the club. Our lawful basis for processing your personal is that we have a contractual obligation to you as a member to provide the services you are registering for.

Reasons we need to process your data include:

For training and competition entry

- sharing personal data with Team Mangers to enter events;
- sharing personal data with facility providers to manage access to the track or check delivery standards; and
- sharing personal data with leagues, county associations and other competition providers for entry in events.

For funding and reporting purposes

- sharing anonymised data with a funding partner as condition of grant funding
- analysing anonymised data to monitor club trends

For membership and club management

- processing of membership forms and payments;
- sharing data with committee members to provide information about club activities, membership renewals or invitation to social events:

Publishing of race and competition results

Marketing and communications

- sending information about promotions and offers from sponsors;
- sending information about selling club kit, merchandise or fundraising.

The club has a Facebook social media page. All members are free to join this page. If you join this page, please note that provider of the social media platform has their own privacy policies and that the club do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data on the club social media pages.

Who we share your personal data with

When you become a First Claim member or renew your membership of the Club, you will automatically be registered as a member of England Athletics (EA). We will provide EA with your Athletics Data which they will use for access to the MyAthletics portal. EA will contact you to invite you to sign into and update your MyAthletics portal. You can set and amend your privacy settings from the MyAthletics portal. If you have any questions about the continuing privacy of your personal data when it is shared with England Athletics Limited, please contact dataprotection@englandathletics.org.

All members will also be registered with British Masters Athletic Federation (BMAF) and invited to access their online portal, details of which can be found on the website: https://bmaf.org.uk.

The Club does not supply any personal data it holds for this purpose to any other third party.

How long we hold your personal data

We will hold your personal data on file for as long as you are a member with us. Athlete data is updated every year on annual membership forms. Any personal data we hold on you will be securely destroyed after four years of inactivity on that member's account, in line with EA's retention policy. Your data is not processed for any further purposes other than those detailed in this policy.

Your rights regarding your personal data

As a data subject you may have the right at any time to request access to, rectification or erasure of your personal data; to restrict or object to certain kinds of processing of your personal data, including direct marketing; to the portability of your personal data and to complain to the UK's data protection supervisory authority, the Information Commissioner's Office about the processing of your personal data. As a data subject you are not obliged to share your personal data with the Club. If you choose not to share your personal data with us we may not be able to register or administer your membership.

IOMVAC promise to you regarding your personal data

- We will only ask for the relevant data to enable us to administer your membership
- We will store your data in a safe, responsible manner and that storage may be electronic or paper based
- We will keep your data up-to-date and allow you to change it by informing the Membership Secretary
- We will only share your data with England Athletics and BMAF so as to give you access to their services. We will not share your data with any other external organisation without your explicit authority
- We will, as necessary, release data regarding race and competition results to relevant sports
 news publications, on our website and social media. This data will typically be restricted to name
 and age group

- We will remove your data from the records that we hold when you cease to be a member of IOMVAC and will inform EA and BMAF. We will not be able to remove your details from historic data relating to race results and competitions.
- We will review our policy and procedures regarding GDPR on a regular basis.
