

PRIVACY NOTICE

The Isle of Man Veteran Athletes' Club (IOMVAC) is committed to protecting and respecting your privacy. For any personal data you provide for the purposes of your membership, IOMVAC is the **Data Controller** and is responsible for storing and otherwise processing that data in a fair, lawful, secure, and transparent manner.

What Personal Data We Hold on You

You may provide us with information through event registration forms, online submissions, or by corresponding with us via phone, email, or other channels. This information may include:

- Name
- Date of birth
- Address
- Email address
- Phone number
- Affiliated clubs (e.g., EA)
- Gender
- Special Category Data, such as health data (only when necessary for participation in events)

Why We Need Your Personal Data

We require your personal data to manage your membership and deliver the services you have signed up for. Our legal basis for processing your data is a **contractual obligation** to provide these services. We process your data for the following reasons:

For Training and Competition Entry:

- Sharing personal data with team managers to enter events.
- Providing data to facility providers to manage track access and monitor delivery standards.
- Sharing information with leagues, county associations, and other competition organisers for event entries.

For Funding and Reporting:

- Sharing anonymised data with funding partners as part of grant conditions.
- Analysing anonymised data to track club trends.

For Membership and Club Management:

- Processing membership forms and payments.
- Sharing data with committee members to provide updates on club activities, renewals, and social events.

- Publishing race and competition results.

Marketing and Communications:

- Sending promotional information and offers from sponsors.
- Notifying members about club merchandise, kit sales, and fundraising events.

Opt-Out Conditions

You can **opt-out** of receiving marketing communications by contacting us directly at iomvaclub@yahoo.co.uk. If you opt-out of sharing your personal data for certain purposes, we may be unable to provide specific membership services.

Who We Share Your Personal Data With

Upon joining or renewing your membership with the Club, you will be automatically registered with **England Athletics (EA)** and **British Masters Athletic Federation (BMAF)**. We will share your Athletics Data with these organisations to provide you access to their services. You will be invited to manage your data and privacy settings via their respective portals. Please consult **EA** and **BMAF's** privacy policies for further details.

The Club does not share your personal data with any other third parties, except as required for legal obligations or as necessary for event organisation.

Special Category Data

Where necessary, we may process **Special Category Data**, such as health information, to ensure your safe participation in events or to meet specific health requirements. This data will only be processed with your **explicit consent** and shared only with those who require it for health and safety purposes. You may opt out of this data sharing by contacting iomvaclub@yahoo.co.uk. However, this may impact your ability to participate fully in events.

Data Retention

We will retain your personal data for as long as you are an active member. Membership data is updated annually, and we securely delete personal data after four years of inactivity, in accordance with **EA's retention policy**. Special category data will be retained only for the duration of its intended use and will be securely deleted thereafter.

Your Rights

You have the following rights regarding your personal data:

- Access your data and request rectification or erasure.
- Restrict or object to the processing of your data.
- Opt-out of direct marketing.
- Request portability of your data.
- Lodge a complaint with the **UK Information Commissioner's Office** if you believe your data has been mishandled.

IOMVAC's promise regarding your personal data

- We will only request data necessary to administer your membership and ensure your participation in club activities.
- We will store your data securely, whether electronically or in paper form, and will take all reasonable steps to ensure its protection.
- You can update your data at any time by contacting the Membership Secretary.
- We will share your data only with EA and BMAF for the purposes of giving you access to their services. We will not share your data with other third parties without your explicit consent.
- Race and competition results, including names and age groups, may be published in sports news publications, on our website, or on social media.
- We will remove your data from our records when you cease to be a member of IOMVAC, but we may retain historic data relating to race results and competition participation.
- We will review our GDPR policies and procedures regularly to ensure ongoing compliance.
